

RESOLUTION

Recognizing the Outstanding Service of Gaile L. Moe

WHEREAS, **Gaile L. Moe** has provided Seattle Pacific University with 25 years of extraordinary service as Professor of Family and Consumer Sciences and Director and Associate Dean of General Education and Undergraduate Curriculum (for the past four years);

WHEREAS, she has established herself as an exceptional instructor, trusted advisor, gracious mentor, and highly valued colleague;

WHEREAS, she has expertly taught numerous (19) courses related to food and nutritional sciences to hundreds of students throughout the years;

WHEREAS, she contributed significantly to dietetics education by co-authoring four editions of Wardlaw's Perspectives in Nutrition, a textbook for university courses in nutrition;

WHEREAS, she served as Director of the accredited Didactic Program in Dietetics (DPD), successfully moving the program through the newer, more rigorous accreditation process;

WHEREAS, she invested extensive amounts of time and energy into mentoring dietetics students and helping them launch into dietetics careers. She completed 190 Verification Statements for students applying for Dietetic internships. The SPU Dietetics program experienced a high acceptance rate for the post-baccalaureate internships, well above the national average, with approximately 67% of them completing the dietetics internship, taking the RD exam, and becoming registered dietitians. They now work in a variety of institutions across the United States, contributing to the field of nutrition and dietetics;

WHEREAS, she collaborated with University administration to extensively remodel the foods lab in lower Peterson Hall and managed the design, planning, and implementation and evaluation of the remodel;

WHEREAS, she has led the development of several programs, including the first-year writing curriculum, University Colloquium, and Ascent, and has diligently supported and advanced University Scholars, General Education, the Night Against Procrastination event, the CUE requirement, and New Student Advising (NSA) programs;

WHEREAS, she served the University generously and competently as both a member and/or the chair of numerous faculty review committees, search committees, and task forces; and

WHEREAS, her deep and abiding Christian faith has been shown through her relationships with all her colleagues, students, and alumni. For all this and much more, we thank her and honor her; therefore, be it

RESOLVED, that we congratulate **Gaile L. Moe** for her years of dedicated service to Seattle Pacific University, and we extend our heartfelt appreciation for her numerous contributions to the life of our community; and be it further

RESOLVED, that we bestow on **Gaile L. Moe** the status of *EMERITA PROFESSOR OF FAMILY AND CONSUMER SCIENCES*, with all the rights and privileges accompanying such rank, yet understanding that no title nor honor can fully convey our lasting appreciation and knowledge of how richly she has deserved all that is in our power to bestow.
